



PERMISSION TO DRIVE/PARK A CAR AT HHCS



Permission to drive to school is granted as a convenience, and is a privilege not a right, for students, and is subject to space availability. Criteria for the allocation of student parking permission will be made by the administration on an annual basis. If a student fails to follow the auto rules and procedures, his/her driving permission may be revoked.

1. Driving to school is a privilege. ANY infraction of school rules can result in the loss of driving privileges. **Any unsafe driving on school property will result in loss of driving privileges.**
2. The speed limit on school grounds is **10 MPH at all times**. Speeding and/or reckless driving of any type will result in the loss of driving privileges.
3. Students MUST park in the student parking area designated by the administration and not parked in any other area unless instructed to do by administration. Parking on grass is not permitted at any time.
4. Students riding in cars with a student driver must have written parent permission, on file in the main office. Both the driver and the passenger(s) are responsible for adhering to this rule.
5. Drivers should plan on arriving at HHCS at least 10 minutes prior to the start of the school day. During inclement weather, students should plan accordingly. Vehicle, weather and traffic related excuses will not be accepted.
6. **Students MUST proceed into the building immediately upon arrival at school!**
7. **If a student receives four or more tardies, to school, in a quarter, his/her driving privileges will be suspended for a minimum of 10 school days. If this occurs in more than one quarter, in the same year, driving privileges can be suspended for 30 days.**
8. If there is reasonable suspicion that a weapon, any substance covered under HHCS drug and alcohol policy, or anything endangering the health and welfare of students is in a student's vehicle, the vehicle may be searched with the student present.
9. If an accident occurs on school property, it must be reported to the Main Office within (24) hours. The student(s) involved, and their parents/guardian, assume full responsibility for all financial, legal and insurance requirements regarding all accidents.
10. No student is allowed to go into the parking lot during the school day unless authorized by a member of the HHCS Administration. Students will not be allowed to enter the parking lot to retrieve forgotten homework or other forgotten materials or equipment.
11. Unauthorized vehicles will be towed at the owner's expense.
12. **FAILURE TO COMPLY WITH ALL OF THE DRIVING REGULATIONS WIL RESULT IN THE REVOCATION OF THE STUDENTS PARKING PERMISSION AND FORFEITURE OF DRIVING PRIVILEGES.**
13. Remember, driving is a privilege not a right. Student drivers must adhere to all school rules and regulations in order to keep this privilege.
